

ProQuest introduces the next addition to the UK Parliamentary Papers collection – Public Petitions to Parliament, 1833-1918. The collection includes Records of the Select Committee on Public Petitions, allowing researchers to gain insight on the formative role of petitions to Parliament during the 19th century (1833-1918), an unparalleled period of political modernization and democratization in Britain.

Public Petitions to Parliament are very important indicators of the views and priorities of both the populace and Parliament. How Parliament addresses the petition, or doesn't address it, is a stark indicator of political and social priorities.

Petitioning was by far the most popular form of political participation, but it has long been overlooked by historians and social scientists preoccupied with elections and election rituals, campaigns to extend the right to vote, and the rise of national political parties. However, the utility to scholars of public petitions is not just limited to political historians studying the groundswell of public pressure for the expansion of the voting franchise.

This material appeals to all social, cultural, and religious scholars of Britain, and contains materials on:

- Petitions on ecclesiastical issues.
- · Crime and criminals.
- Colonies, taxation, education, and every other issue of interest to the populace of Britain.
- Religious scholars interested on Methodism and the Church of England.
- Scientists concerned with pollution and pollution controls during the Industrial Revolution.
- Sociologists concerned with how these issues were influenced by the people.

The popular constitutionalism inherent in this collection (as opposed to the "top down" approach to looking at history), is at the cutting edge of historical research today and has wide appeal across campus.

Included are individually rekeyed metadata records for every one of the more than 950,000 petitions accepted by Parliament between 1833-1918.


