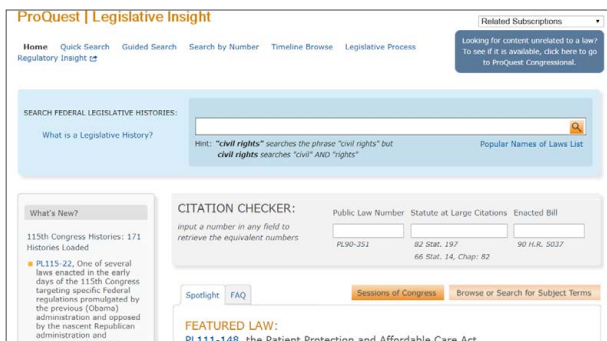

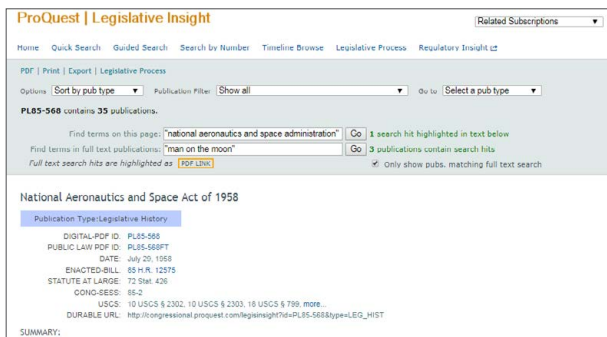

This large collection of legislative histories of U.S. public laws compiled according to a single standard is not available anywhere else. Our professional researchers read the publications to follow the trail leading from the enacted law back through multiple Congresses as appropriate until they reach the first document that is directly related.

Each history includes fully searchable PDFs of all of the publications generated in the course of the law making, including the full text of the public law itself, all versions of related bills, law-specific Congressional Record excerpts, House and Senate documents, and committee hearings, reports, and prints.

Also included are presidential signing statements, CRS reports, and miscellaneous congressional publications that provide background material to aid in the understanding of issues related to the making of the law.

- Discover the legislative intent behind a specific law and improve understanding of the legislative process
